<b>21/058</b> 21/058/1	Clerk's Report: Allotment Water Leak – A leak was reported and the water turned off. Cllr Pete Eden carried out a temporary repair and the supply was restored to 4 of the standpipes. A complete repair will be carried out as soon as parts can be sourced.	
21/058/2	No mow May – The verges are due to be mowed this month. Feedback on the trial has been mixed with some parishioners in support and others against.	
21/058/3	Annual Meeting – Linda Newberry has confirmed that the Barford Environmental Network will give a presentation at the annual meeting. It was decided not to invite the Hook Norton Low Carbon Group this year as attendance at the meeting may be low due to COVID-19.
