25/050	Planning: MW.0009/25 – North Oxfordshire Topsoil – Increase vehicle movements from 12 to 24 per day – The PC has objected to this application. Some residents commissioned expert reports to support the objections made by residents and the PC. It was agreed that the PC would not contribute to the cost of these reports as it would set a precedent for future applications.	
25/051 25/051/1	Reports from Meetings: South Newington PC meeting to consider planning application MW.0009/25 – Cllr Sandi Turner attended the last Soth Newington PC when this planning application was discussed. South Newington does not have a parish news.	
25/051/2	Hall & Fernhill Trust – Cllr Sandi Turner has been invited to attend a meeting to discuss how to use the funds from the sale of the field that they owned.	
25/052 25/052/1 25/052/2	Finance: Payments – The clerk gained approval for payments totalling £3,177.24. Internal and External Audits – It was agreed to ask Jeremy Eastwood to carry out an internal audit of the accounts and to submit a Certificate of Exemption to External Audit.	
25/053 25/053/1 25/053/1	Any Other Business: Toads Crossing Sign – A resident asked the PC to consider paying for a Toads Crossing Sign on the road to South Newington. This will be considered further by the PC. Dog on dog attack and meeting with the CDC Dog Warden – Another incident was reported of a dog being attacked by another dog. This was reported to the CDC Dog Warden who advised: - Dog on dog attacks should be reported to the dog warden - Dog on people or livestock should be reported to the police - People on dogs should be reported to the RSPCA In addition the dog warden advised: - CDC do not distinguish between dog waste bins and general waste bins which can be used for disposal of bagged dog poo but if people put dog waste from their own gardens into public waste bins it is classed as Fly Tipping. Tree overhanging road outside the Manor House – A resident reported a branch falling into the road from the Manor House and that other branches looked unsafe. Cllr Ray Cox agreed to report this on Fix My Street.
